Get Ready for the upcoming Hunt Test Season!

This weekend is specifically designed to help handlers, judges and potential judges run actual test situations. Participants will receive expert coaching tips and will learn more about test mechanics, setups, scoring and CKC Hunt Test Rules. This informal picnic hunt test is hosted by Barry Kolodychuk of Streamline Retrievers, aided by Rick Regamble of Willow Wind Kennels and hunt test rule book enthusiast, Bonnie McGhie. The purpose of this event is to have fun and improve our game. It will increase handlers success and give judges more tools and confidence in taking assignments.

- There will be birds and hired gunners
- You will be permitted to come to line with training aids
- You will be permitted "one rerun" if you need to correct your dog at line
- You will have professional help at line if you wish
- Your dog will be scored by three judges
- You will get marks and blind(s) plus honouring
- Test set up will have land and some water plus decoys
- There will be a short discussion about dog scores on each mark/blind

The test mechanics and set up will be thoroughly explained to the group. There will be options for handlers to pick and choose order of the marks. This event is more focused toward senior and master level dogs. **All hunt test dogs are welcome, but should be at an accomplished junior level or better.**

Fee: One Working Dog \$50, Two dogs \$80 Participant with No Dog \$25

Please mail/email your entry by March 17th. Dog entries are limited to 30 dogs total (15 Senior Dogs and 15 Master Dogs)

Start Time is 9am at Popkum Reserve on Julseth Rd, Popkum, BC.

Will go all day on Saturday and until 2 pm Sunday. Weather permitting there will be a tailgate BBQ on Saturday. Please bring a chair, notebook and appropriate clothing and gear.
