*You, on your own behalf and on behalf of your heirs, legal representatives, successors and assigns (collectively, "YOU"), are being asked to sign this **RELEASE** in connection with your registration as a member (or a member's joining spouse) of the Fraser Valley Retriever Training Club ("FVRTC") or **YOUR** being allowed as an event participant or spectator or in any other capacity, to enter certain real property (the "Grounds") used or leased by the FVRTC. The Grounds include the real property leased by the FVRTC from the Township of Langley and the adjacent real property leased by the Operator Training School at 26859 – 8<sup>th</sup> Ave., in the Township of Langley identified in Appendix "A" of this **RELEASE** agreement. In addition to your agreeing to the provisions of this **RELEASE**, you must also comply with all the terms and restrictions governing **YOUR** use of the Grounds as set forth in the Rules of Conduct page of the FVRTC's website ([www.fvrtc.com](http://www.fvrtc.com)) and/or other documentation provided to you in connection with your entry into the Grounds.*

*This **RELEASE** benefits the FVRTC, the sponsors of any retriever trials or events on the Grounds, and all the owners, lessors, and licensors through whom the FVRTC has obtained and enjoys the rights to use the Grounds.*

*The FVRTC and such sponsors, owners, lessors, and licensors, and their respective partners, officers, directors, shareholders, members, agents, employees, beneficiaries, successors and assigns and any other individual associated with any of them are collectively referred to as the "**Owners.**"*

*The Grounds may be improved or unimproved. There are certain natural and man-made hazards that may exist on the Grounds. None of the **Owners** makes any representations regarding the conditions of any of the Grounds. Entry into the Grounds is at **YOUR** own risk. If you nonetheless choose to use any of the Grounds, **YOU** agree that **YOU** alone will bear all risk of injury or damage to **YOUR** person, dogs and/or property and that **YOU** alone will be responsible for any injury that **YOU**, **YOUR** guests, or **YOUR** dogs cause while on the Grounds. Before you use any the Grounds **YOU** should be sure that **YOU** have adequate insurance to cover any and all risks of use. In consideration of the privilege of entering any of the Grounds under the terms of your FVRTC membership or event registration materials or otherwise, **YOU** hereby agree as follows:*

- 1. To the fullest extent allowed by the law, **YOU ASSUME ALL RISK** of damage to property or injury to or death of persons and/or dogs in, or upon or about any of the Grounds and **YOU** further **WAIVE, RELEASE AND FOREVER DISCHARGE** the **Owners**, and each of them, from and against any and all claims, losses, judgements, liabilities, injuries (including, without limitation death), causes of action, costs and expenses (including, without limitation reasonable legal fees and costs and all reasonable investigative and discovery costs) arising from or in connection with **YOUR** use and/or enjoyment of the Grounds.*
- 2. In further consideration of the privilege of entering upon any of the Grounds, **YOU** agree at **YOUR** expense to **INDEMNIFY, DEFEND, PROTECT,** and **HOLD HARMLESS** the **Owners** (and each of them) from and against any and all Claims for injury (including, without limitation, death and physical, psychological and emotional injuries) to any person and/or dogs, or damage to any property whatsoever, arising from or caused by (whether in whole or in part, directly or indirectly) any acts, omissions, negligence, recklessness, or willful misconduct of **YOU**, **YOUR** guests or any other persons **YOU** permit to be on the Grounds (each, a "Guest") or **YOUR** (or a Guest's) participation in any event held on any of the Grounds.*
